

OFFICIAL RULES OF THE FOREIGNER I WANT TO KNOW WHAT LOVE IS FLYAWAY SWEEPSTAKES

Entrant may submit a photo as indicated during entry at Entrant's discretion. Photo submission is not a requirement to enter or to win. Photo is for entertainment purposes only. Winners will be selected in a random drawing and Photo will have no bearing in winner selection.
